Presidents Letter

At our year end general meeting on December 5th we recapped for those present the major accomplishments of the past year, presented the proposed operating budget for this coming year, and reelected to the Board Mike Fay and Barry Schoer. So for the coming year the composition and slate of officers of the Board will remain the same as it was for last year. We would like to encourage you to consider helping us out either by joining us on the Board or by volunteering to help out in specific areas. Tasks that would be very helpful include acting as assistant Treasurer, welcoming new residents to the Ranch providing them with a Ranch roster and emergency network information, coordinating and

generating material for our newsletter, and of course, joining us on the Board to make your voice heard. We meet on the second Tuesday of each odd numbered month with the location varying, so contact us if you would like to attend.

We'd like to thank the owners of the corner lots on Camino Manadero and Camino Meleno for cooperating with our entry landscape efforts. The recent rains have made the entries look pretty good but they have also promoted a lot of vegetation growth throughout the Ranch. Please try to be mindful of how the vegetation on your lot could potentially impact traffic flow for both pedestrians and vehicles in the Ranch keeping in mind that we want to keep the Ranch a safe place for everyone, residents and visitors alike.

Neighbor Spotlight - Thomas and Irene Bird

Remember when 60 was "old"? Times have changed. Neighbors Thomas Bird (101) and his wife of 78 Years, Irene (97) moved into the Ranch in 1967. They are the original owners of their barn-themed house, set back on the long, winding driveway by the creek at 1160 Camino Meleno. Their son-inlaw, Loren Barringer, lives in the house farther back on the same driveway.

Thomas was born in Brea, California, in 1922 (his 102nd birthday will be on May 7). His family moved to Warrenburg, Missouri when he was in grade school - a reverse of the Dust Bowl migration. The Birds became friends with Irene's family,

who were nearby dairy farmers. After high school, Thomas served in the Coast Guard from 1942 to 1944, then worked as a civilian at an Air Force base in Missouri. He and Irene married in 1945. They adopted two children, Brad and Linda (both since deceased) and moved to Lompoc, where Thomas worked for the Johns-Manville Diatomite Production Plant. Thomas worked at other jobs, and was a member of the Sheet

Metal Workers' Local Union No. 104 for 38 years. Meanwhile, Irene earned an AA at Allan Hancock College, and worked in the personnel office for the Federal Prison Complex in Lompoc. She continued with this job for 27 years, most of that time commuting to Lompoc from Rancho del Ciervo. The children attended Santa Barbara Christian School, and the family were members of Emmanuel Lutheran and Good Shepherd Lutheran churches.

When they were raising their family, the Birds were frequent campers. After retirement, Thomas and Irene traveled the world, visiting China and seeing most of Europe.

With his experience on the farm in Missouri, and in his hands-on career, Thomas has always been a builder. He built an addition to their house, and over the years has undertaken numerous projects on the property.

The Birds have a painting of the original bridge - painted on a steel brace that was part of the bridge! Thomas built a footbridge after the original bridge collapsed. That footbridge held until the floods of 1995.


Thomas and Irene were close friends with Carlo Girardi, the director of development for the Ranch in the 1960's. During that time, Carlo lived in the back house, and the Lillard-Catlett house (now Alice Birch's residence) served as the office for the developer. The Birds have several black-andwhite historical and promotional photographs from that time. We plan to publish these in future newsletters.

- If you have construction, please make sure the side of the road is cleaned up (removing dirt, rocks, etc.).

2023 Financial Report

Following the discussion at the December, 2022 General Meeting, the Board kept the annual dues at \$100/year (although at the same meeting, over two-thirds of general membership voted to raise the dues "ceiling" to \$125/year). The Board intends to keep the dues at \$100/year until the end-of-year bank account balance drops to a level of \$7,000 or so, which is about half of the annual budget. At that point we can consider cutting expenses or raising dues. As of December 31, 2023, the bank balance (our only financial asset) stood at \$14,835.24. At our current burn rate, a balance of \$7,000 is about 2 years away.

In 2023, the Board, following the consensus of the membership, funded various landscaping maintenance and tree-trimming projects that were deemed to be of general benefit – even though they occurred on private property (always with the owners' permission and involvement). Facing a bit of a backlog, this extraordinary expense came to \$5,530. We've budgeted for about half that in 2024. (This item appears as "Gardening Cleanup".)

Several non-recurring line items, for which there were no expenditures in 2023 and none budgeted for 2024, have been removed from this year's report. They are "Gates: Landscape Design/
